Sharad Pawar's resignation as NCP chief on Tuesday surprised his party as well as his Maharashtra allies Uddhav Thackeray and Congress. Hours later, amid a dramatic show of distress from partymen, Sharad Pawar agreed to "rethink" and said he needed "two-three days".

As soon as Sharad Pawar, 82, dropped the bombshell on Tuesday afternoon at the launch of his autobiography, NCP leaders crowded the stage. Some leaders wept and many said they would stay put unless the veteran changed his mind. In the presence of his wife Pratibha

Pawar, daughter Supriya Sule, and nephew Aiit Pawar, he apparently made the announcement out of the blue.



In comparison, Pakistan climbed China up seven ranks to reach 150 this constitution year.

Texas man accused of killing five neighbors last week,

arrested A man accused of massacring five neighbors after they asked him to stop firing his rifle in his yard in Texas was captured Tuesday after a days-long manhunt, US media

reported. Francisco Oropesa had eluded Texas authorities after the shooting Friday in the small town of Cleveland.

The victims were between the ages of nine and 31.

Oropesa was arrested in the Texas town of Cut and Shoot, about 17 miles from the Cleveland, San **Jacinto County District Attorney** Todd Dillon told broadcaster NBC. As authorities deployed hundreds of law enforcement officers to look for the 38-year-old, they also offered an \$80,000 reward for information leading

Lucknow: In a shocking and shameful incident, two policemen who are duty bound to protect the citizens, allegedly turned violators and sexually assaulted a woman in Uttar Pradesh.

A woman accused a constable posted in Pilibhit and his elder brother, posted as a policeman in Shamli district of repeatedly raping her and also forcing her to undergo abortion twice.

In her complaint, the 26-year-old woman accused the two Uttar Pradesh policemen of repeatedly raping her after keeping her in confinement for

The woman came in contact with Constable Imran Mirza through Facebook in March 2021. The woman alleged Mirza promised to marry and raped her several times in different hotels.

Imran Mirza is also a resident of Shamli. The woman alleged that Mirza provided her accommodation in a rented flat in Shamli where his elder

. brother, Furgan, also raped her. As per the complaint filed by the woman, she became pregnant twice and was forced to abort by Imran both times.

The woman alleged that when she confronted Imran, she was brutally thrashed and given death threats to withdraw the case

"I remained quiet for two years. When I confronted him recently, I was brutally beaten up. That is when I decided to take legal action. Now, I am getting death threats from Imran and his brother to withdraw the case," the woman was quoted by IANS.

Giving details of the case, Superintendent of Police (SP) (Pilibhit) Atul Sharma said that the initial investigation reveal that the woman belongs to a different community. He assured of appropriate action if the two policemen are found guilty.

'The key accused, Imran, had taken a long leave and was expected to rejoin duty on May 3. Action will soon be taken in the matter." the top cop said

The two attackers, identified as Rahul Tyagi and Jagdeep, entered a crowded Rohini courtroom posing as lawyers and shot dead gangster Gogi. Both assailants were shot dead by the police in retaliatory firing

DELHI: BODY STUFFED IN DELIVERY BAG FOUND IN NAJAFGARH **COUPLE ARRESTED**

Delhi crime news: Body of a man, aged between 20-25 years, was found in a large bag, commonly used for e-commerce deliveries, in Delhi's Najafgarh drain, an official said on Tuesday (May 2). The deceased was identified as Umesh, a

resident of Vikas Nagar. According to police, a PCR call was received that a large bag has been thrown in Najafgarh drain opposite dump yard at Shiv Vihar JJ Colony in Uttam Nagar, following which a police team rushed to the spot.

"Body of a man was found in the said large bag. A case under relevant sections of the IPC was registered at Uttam Nagar police station and further investigation was taken up," said M Harsha Vardhan, the Deputy Commissioner of Police

(Dwarka). On investigation, it was revealed that the deceased had gone to the room of his acquaintance Sunny, known to him, for taking some intoxicating substances where others were also present.

"Scuffle took place there and he was murdered on April 30 evening hours. Subsequently the accused tried to dispose off the body by dumping it in a bag on May 1," said Vardhan. The official said that they have arrested the accused identified as Subham alias Viraj and his wife Fatama while the third

accused Sunny is still absconding.

INDIAN BUDGET AIRLINE GO FIRST HAS CANCELLED ALL OF ITS FLIGHTS FOR

The carrier says "A full refund will be issued" to affected customers.

It is the first major airline in the country to file for bankruptcy since Jet Airways went bust in 2019 Go First blamed US engine maker Pratt & Whitney for having to ground many of its planes, which it says caused a severe cash flow problem.

The company "had to take this step due to the ever-increasing number of failing engines supplied by Pratt & Whitney," Go First said in a statement.

Go First said that the problem forced it to ground 25 aircraft - about half of its fleet of Airbus A320neo planes - which caused about 108bn rupees (£1bn; \$1.3bn) in lost revenue and expenses. The airline also accused Pratt & Whitney of not following an order by an emergency arbitrator, which included supplying "at least 10 serviceable spare leased engines by 27 April 2023". In response, Pratt & Whitney said it was "complying with the March 2023 arbitration ruling" and it cannot

comment further as "this is now a matter of litigation". India's Civil Aviation Minister Jyotiraditya Scindia said:" The government of India has been assisting the airline in every possible manner.'
