Two terrorists were killed in an 🎬 encounter with security forces in the Baramulla district of Jammu and Kashmir, police said. The encounter broke out in the early hours of Thursday in the Wanigam Payeen Kreeri area of Baramulla after security forces landed a cordon and search operation acting on specific input about the presence of militants, reported PTI.

According to police, the search operation turned into an encounter after the militants fired upon a search party of the forces, who retaliated. Police said incriminating materials, arms and ammunition, including an AK 47 rifle and a pistol, were recovered from the terrorists killed in the encounter.

#### World <u>Russian Decoys</u> Trick Ukrainian Air Defense While **Kh-101 Stealth Missiles Deliver A Painful Blow**

Russian cruise missiles struck a facility in the Ukrainian city of Pavlograd in Dnipropetrovsk Oblast, causing massive mushroom cloud blast, which by all reckoning was the granddaddy of all blasts so far in the conflict. The RuMoD cryptically stated on May 1, 2023, "The Armed Forces of the Russian Federation launched a long-range high-precision air and sea-based missile strike against military-industrial Ukrainian complex facilities.

"The goal of the attack has been reached. All the assigned targets have been neutralized. enterprises producing ammunition, weapons, and military equipment for Ukrainian forces have been disrupted."

Multiple social media sources report that the likely target in Pavlograd was a plant in the city used for producing missile fuel and explosives.

#### MUMBAI MAN LOSES RS 1.3 CRORE TOMUMBAI LIKE ON YOUTUBE & EARN' IOB FRAUD



MUMBAI: The west region cyber cops are probing a part-time job fraud in which a 47-year-old man working with a marketing company was duped over Rs 1.33 crore. The cyber fraudster lured the complainant by promising high earnings for watching and liking YouTube videos and convinced the complainant to transfer money to 25 different bank accounts between January and March this year.

'The complainant had got a WhatsApp message asking him if he was interested in a part-time job that could earn him between Rs 5,000 to Rs 7,000 per day. During the chat, the message sender explained that he would send YouTube videos, and his job would be to watch, like and take a screenshot and send it to the same WhatsApp number. He was asked to pay Rs 5,000 for registration and other fees. He then received a link to a YouTube video and followed the instructions. He also received Rs 10,000 in his account," said a police officer.

The accused then asked the complainant to join his Telegram group and said he would be given different tasks to complete which could earn him a huge earning. Convinced, the complainant joined the Telegram group. "He was asked to deposit money as an investment and was given different tasks to complete. The accused told him he would make a good profit once he completed the tasks," said a police source.

In a job fraud, the accused usually tells the victims that they have a contract to promote certain companies, channels or brands for which they employ people on part-time jobs. When the complainant demanded a return of his invested money and profit, the fraudster claimed he had not done his job properly and demanded more money. This is when the complainant lodged an FIR. A police probe found that the complainant had sent money to 25 different bank accounts. The accounts were opened in the name of fake companies, said an officer.

DCP Balsing Rajput of the cyber crime wing of the Crime Branch advised citizens against following any message or link received from an unknown person/source. "Generally, the accused in such fraud cases give different bank account numbers each time; this should raise suspicion. Moreover, the initial profit in such cases also comes to a victim from a third party or a different account. These are signs of fraud one must be aware of in case anyone gets a part-time job message. One must immediately approach the police," said Rajput.

Mumbai police have exposed a ring of cybercriminals that stole money from people from across the country by posing as police personnel and arrested its kingpin, who has studied till Class 12 and used to do transactions of more than Rs 5 crore a day in his accounts, an official said on Wednesday.

Mastermind Shrinivas Rao Dadi (49), who has sound technical knowledge despite limited education, was taken into custody by a team of Bangur Nagar police station from a plush hotel in Hyderabad, the official said.

Besides Dadi, police also arrested four more members of his gang, including two from neighbouring Thane and as many from Kolkata, he said.

Dadi pretended to run a real estate business and used to communicate only through the Telegram app. Police have so far frozen 40 bank accounts used by Dadi and recovered cash of Rs 1.5 crore from him, the official said.

Explaining the modus operandi of the cyber fraudsters, the official said that Dadi and his accomplices would call people, mostly women, posing as police officers and tell them that cops have found drugs or weapons in a courier sent by them, he said.

The caller would then demand the bank or income tax-related details saying those were needed to verify if the courier didn't belong to the person they were speaking with.

Ajay Kumar Bansal, deputy commissioner of police (zone -11), said most people would get scared by the phone call and share their bank or IT details. Victims also shared the one-time password (OTP) and in some cases allowed the fraudsters to take control of their mobile phones by downloading apps like AnyDesk, the official said

#### THANE: 65-YEAR-OLD WOMAN FALLS TO DEATH FROM A GALLERY HIRANANDANI ESTATE

A 65-vear-old woman falls to death from her gallery on Wednesday, May 3, at around 5 pm. The incident took place at the B wing of the Fortuna building a ground plus 22 floors apartment at Hiranandani Estate in Thane.

Avinash Sawant, regional disaster management cell (RDMC) chief, Thane said, "On Wednesday at around 4:45 pm we received information that in the 'B' wing of Fortuna building in flat number 503 gallery of 5th floor Rohni Mulki (65) fell on the 2nd-floor gallery of flat number 203 and died on the spot."

Sawant added, " The Police personnel of Kasarwadvali police station along with 1 ambulance and disaster management cell personnel with 1 pickup vehicle and fire brigade personnel with 1 rescue vehicle were present at the incident spot. The body of the woman has been handed over to Kasarwadvali police personnel and it has been sent to district government hospital in Thane for post-mortem."

The case of accidental death report has been registered at the Kasarwadvali police station and police are further investigating the case.

#### USE OF LOUDSPEAKERS: HO THREATENS TO HOLD DCP IN CONTEMPT IF POLICE DON'T ACT AGAINST KANDIVALI MOSQUE

The Bombay high court on Wednesday warned the deputy commissioner of police (DCP), zone XII, of initiating contempt proceedings against him if the police failed to comply with a court order that bans use of loudspeakers in silent zones and to act against a mosque in Kandivali for violating the noise pollution norms.

A division bench of justice Revati Mohite Dere and justice Sharmila Deshmukh was hearing a petition filed by advocate Reena Richards, a resident of Thakur Village in Kandivali East. The plea claimed that though the mosque was in a silent zone it was using loudspeakers in the early hours for the call to prayers.

The petitioner told the bench that after she had lodged a complaint against the violation in 2017, and after an HC bench had passed on order in this regard that year, the police put a stop to it. However, the mosque resumed using loudspeakers in 2022 and though she again complained to the police station concerned, there was no action. Richards said in her plea.

The HC had on Tuesday sought the presence of the DCP, Ajay Bansal. On Wednesday, Bansal, who holds the

additional charge of zone XII, told the bench that after the petitioner had complained about the noise pollution, he had taken suo motu cognisance of the matter.
