

UMESH PAL MURDER CASE: ANOTHER ACCUSED USMAN SHOT DEAD IN POLICE ENCOUNTER IN PRAYAGRAJ

ANOTHER ACCUSED IN THE UMESH PAL MURDER CASE, USMAN, HAS BEEN SHOT DEAD BY POLICE IN AN ENCOUNTER.

Umesh Pal Murder Case: Another accused, Vijay alias Usman has been shot dead by the Prayagraj police in an encounter on Monday. This is the second in the massive crackdown by the police after it neutralised one accused in a similar encounter in the Nehru Park area of the city.

Dr. Badri Vishal Singh, Emergency Medical Officer, Swaroop Rani Nehru Hospital, Prayagraj confirmed the news to reporters. He said, "Patient Usman was brought dead. We performed the examinations following which he was declared dead & the body was sent to the mortuary."

Uttar Pradesh BJP MLA Shalabh Mani Tripathi also tweeted with the photo of the accused, "Dreaded murderer Usman shot dead in an encounter with Police today."

An encounter broke out earlier in the day between the police and one of the accused in the Umesh Pal murder case Vijay alias Usman in the Kaundhiyara police station area of Prayagraj.

Reacting to the development, UP deputy CM Brajesh Pathak told ANI, "Police & STF deployed to keep situation under control, & investigation is underway. Police shot the accused & are investigating. Everyone involved will get punished by the law."



MAHARASHTRA: MINOR DETAINED IN NAGAR IN HSC PAPER LEAK CASE

A COLLEGE IN MUMBAI HAD LODGED AN FIR AFTER A MOBILE PHONE WITH THE MATHS QUESTION PAPER ON WHATSAPP WAS FOUND WITH A STUDENT, WHO WAS LATER DETAINED

The Mumbai Crime Branch detained a minor student from Nagar district of Maharashtra in the HSC paper leak case on Sunday. The math paper was leaked around 45 minutes prior to the exam on WhatsApp. A private college had registered an FIR with the Shivaji Park police after the math paper was found on the cell phone of one of the students who appeared for the exam on Friday. Later this student in Mumbai was also detained.

Supervisor catches student

The paper started at 11 am. According to the FIR, a teacher at Dr Antonio Da Silva High School and Junior College claimed that the supervisor of the school found a cell phone with one of the students after the exams were over and he was collecting the math answer papers. "I called the student in my cabin and the examiner to inform him about the incident as per protocol. We checked the student's mobile phone in front of him and found that at 10:17 am on March 3 he had got the math paper on Whatsapp. It has been forwarded to him from another Whatsapp number," the teacher said in his complaint.

"When we asked the student about the number, he said one of his friends had forwarded it to him," the complaint further reads.

Others also booked

The case has been transferred to the Mumbai Crime Branch to probe the matter further and the Crime Branch has detained one minor student from Nagar district of Maharashtra. "The investigation in the matter is underway," said DCP Prashant Kadam (Detection). The FIR has been registered against the student and three other accused in the case.

Earlier, the English paper was also leaked and was viral on WhatsApp, after which six teachers in Parbhani district were booked by local police.

A court here in Maharashtra has convicted two men from Navi Mumbai for murdering a 42-year-old sanitary worker in 2015 and cutting his body into several pieces and sentenced them to imprisonment for life.

The court of Thane additional sessions judge Rachna Tehra also fined the two- a vegetable vendor and a public toilet supervisor- Rs 10,000 each.

Another accused in the case was handed rigorous imprisonment for five years and fined Rs 5,000 for destroying evidence.

Additional Public Prosecutor EB Dhamal told the court the deceased used to work as a sanitary worker in a public toilet in Navi Mumbai but was sacked over poor performance. The job was given to the brother of one of the accused.

The victim and the accused duo used to drink alcohol together at the public toilet.

Angered by the victim's persistent demands of compensation for losing his job, the duo on July 7, 2015, strangled him to death with a cloth and rope and later cut his body into several pieces. The parts were stuffed into two plastic bags.

Amitabh Bachchan got injured during the shooting of his upcoming film 'Project K' in Hyderabad. The actor shared his health update on his blog and said that he is currently taking a rest at his Mumbai home. It will take a few weeks for him to recover, the actor said.

The actor shared his health update on his blog and said that he is currently taking rest at his Mumbai home. Amitabh Bachchan got injured during an action sequence and suffered a muscle tear to the right rib cage. Big B shared the update on his blog and said that the shoot had to be cancelled as it will take him weeks to recover from the injury.

Following the injury, Amitabh consulted a doctor and underwent a CT scan at the AIG Hospital in Hyderabad and flew back home. Doctors have advised him rest as the injury will take at least a few weeks to get better.

"It's painful while breathing and making movement," the superstar admitted while adding that he is taking medicines for pain relief. So, work has been postponed for the moment," he said.

This is not the first time that Amitabh Bachchan has injured himself while shooting for a movie. The Bollywood superstar had sustained serious injuries on July 26, 1982 while shooting for the movie 'Coolie'. That time, he was hospitalised due to internal bleeding in his lower abdomen.

MUMBAI COURT ACCEPTS JAVED AKHTAR'S APPLICATION SEEKING EARLY HEARING IN DEFAMATION CASE AGAINST KANGANA RANAUT

Proceedings in the case, based on the complaint filed by Akhtar, were scheduled to be heard on April 19. The case will now be heard on March 23 before the Andheri magistrate court.

A magistrate court in Mumbai Saturday accepted an application filed by lyricist-poet Javed Akhtar seeking an early hearing in the proceedings against actor Kangana Ranaut in a defamation case.

Proceedings in the case, based on the complaint filed by Akhtar, were scheduled to be heard on April 19. The case will now be heard on March 23 before the Andheri magistrate court.

Through his lawyer, Jay Bharadwaj, Akhtar filed an application stating that the case was last heard on November 23, 2022, and was listed for hearing after five months. On February 13, Akhtar moved the plea seeking an earlier hearing date.

In his plea, Akhtar said that it was a summary case and he is a senior citizen and sought for the proceedings to commence soon in the interest of justice. The court then sought a response from Ranaut on the plea.

Through her lawyer, Rizwan Siddiquee, Ranaut opposed the application stating that another plea seeking the **examination of her sister and manager**, Rangoli Chandel, was yet to be decided. The court allowed Akhtar's plea scheduling the next hearing on March 23 to decide on the plea filed by Ranaut on whether Chandel can be examined as a witness. The plea was opposed by Akhtar, stating that this was not the stage for witnesses to be summoned on her behalf. He had submitted that as per procedure, he would first get the opportunity to examine witnesses.



'TOUGHEST TIME': BJP'S KHUSHBU SUNDAR SAYS SHE WAS SEXUALLY ABUSED BY HER FATHER SINCE SHE WAS 8

Actor-turned-politician Khushbu Sundar shared her experience of sexual assault as a child. The BJP leader revealed that she was only eight when her father started sexually abusing her.

New Delhi: Bharatiya Janata Party (BJP) leader Khushbu Sundar, who recently took charge member of the National Commission for Women (NCW), shared her experience of sexual assault as a child. The actor-turned-politician revealed that she was only eight when her father started sexually abusing her.

Further, the BJP leader said that she could not speak up against her father over the sexual abuse until she was 15.

In a new interview for Mojo Story, Khushbu said, "Toughest time which took me long... not forget, not forgive... but to put it behind me and move forward was the abuse I faced by my father as a child."

She added, "I think when a child is abused, it scars the child for life and it's not about a girl or a boy. My mother has been through the most abusive marriage. A man who probably thought it was his birthright to beat up his wife, beat up his children, and sexually abuse his only daughter. When my abuse started I was just 8 years old and I had the courage to speak against him when I was 15."

She said that she doubted anyone would believe her and thought that even her own mother won't trust her on this.

She added, "One fear that stayed with me was my mom may not believe me because I have seen her in that environment where there was 'kuch bhi hoyaye mera pati devata hai (no matter what happens, my husband is my God)' mindset. But at 15 I thought that it was enough and I started revolting against him. I was not even 16 and he left us with whatever we had and we didn't know where the next meal will come from."
