INOR GIRLS RESCUED 'S EAST

BEEN TRAFFICKED FROM WEST BENGAL AND WERE BEING CONFINED AT A LOCATION IN THE DISTRICT. BETTIAH: Ten young girls including one from Nepal were rescued by East

Champaran's Kotwa police following a communication from the National Commission for Protection of Child Rights (NCPCR) headquarters in Delhi, police said on Wednesday.

"We have arrested two people, Nandu Yadav and Manjay Yadav, who had forcibly engaged the girls and others in the orchestra troupe," said East Champaran superintendent police (SP) Kantesh Kumar Mishra.

The raid was conducted after the NCPCR told the district police that 4-5 minor girls had been trafficked from West Bengal and were being confined at a location in the district.

"In the course of this investigation, we came across ten girls who were rescued from separate orchestra troupes," said Narmdeshwar Singh, in-charge of Kotwa police station.

Police said it was alleged that the girls were also sexually abused.

A minor girl, rescued in the operation, told HT over phone that she hailed from Nepal's Dhanusa district and came to the district with a man she was in love with. "But he abandoned me here," she said.

Delhi crime news: A 54-year-old man was found dead under mysterious circumstances in a hotel in South Delhi's Safdarjung Enclave area, a senior police official said today (April 1), adding that a murder case has been lodged in connection.

The deceased was identified as Deepak Sethi, a resident of Indirapuram in Ghaziabad. The Safdarjang Enclave police station received a PCR call at around 12:49 pm on Friday (March 31) regarding the death of a person in Baljeet Lodge. A team immediately rushed to the spot, the police said.

'During the initial investigation, it was revealed that Deepak had checked into the hotel at 8:50 pm on Thursday (March 30) along with a woman. However, the woman had left around midnight," Deputy Commissioner of Police (Southwest) Manoj C said.

'Deepak was found dead the next morning with froth coming out of his mouth and some stains in pillow. He had consumed liquor in the room too. The deceased had no stable job for the past 7-8 years and was doing commission work.

The police are trying to trace the woman who was with Sethi.

"In view of the unnatural death in suspicious circumstances, a case of murder has been registered and investigation is underway," the official added.

## IS IT CRIME TO RUN ORCHESTRA BA

Mumbai: I would like to bring your attention to Zone 11 of Mumbai. Under zone 11 there are many Hukha parlour lounge bars, pubs, and orchestra bars. First I would like to mention the differences between these hookah parlour lounge bars, pub, and orchestra bars

#### A BAR

A bar is a location that is licensed to sell alcohol, and often, that's all they serve. Usually, bars are small; you sit at a counter and a bartender serves you your libations. In addition, some bars do serve finger foods, but the menu tends to be limited.

#### A PUB

Short for "public house" a pub also serves alcoholic drinks. As a result, these locations offer more of a "home-like" atmosphere. There may be a bar in a pub, but often, there are tables and chairs, and a bartender or server will deliver your drinks. Food is available, too. There may also be activities available, such as pool darts, or televisions that broadcast sporting events.

#### A LOUNGE

A lounge is similar to a pub, but usually, couches and lounge chairs are available where you can sit back and relax. Of course, drinks are served, and live music may be played, too. There is a good place to enjoy a night of casual, low-key fun.

#### A CLUB

A club offers a more upbeat atmosphere. These locations are usually spacious and feature a dance floor or a stage. Alcoholic drinks are served and may be ordered at a bar within the facility. Some clubs charge a cover fee, and there are even some that require a membership.

#### AN ORCHESTRA

An Orchestra bar is a type of bar or nightclub that features live music performances as part of its entertainment offerings.

Now, I would like to share some important things about hookah parlours lounge bars and pubs:-

1)Minor teenagers are given entry into the hookah parlour pub and lounge bar. 2)Tabaco flavour hookah is served.

3)Maximum girls wear short clothes 4)Songs are played at loud volume from DJ systems After smoking these hookahs served their teenagers get fully intoxicated and can barely walk. Such places are spoiling the future of our younger generation by giving, the entry into such places which cause harm to their physical as well as mental illness. This kind of activity is performed till late at night without any fear of rules and the police. It may be noted that the state government has banned hookah parlours under the Prohibition of Cigarette and Tobacco Act 2003.

What about the orchestra bar:- The orchestra bar owner pays the tax to the govt. for liquor and also pays the tax for the stage where the artist performs. No minors are allowed to enter and it closes as per the government guidelines. Our Debo Times investigation team investigated and observed the activities of above said establishments. In the year 2020 Mumbai high court made the statement that "The Mumbai Police is considered as one of the best in the world after Scotland Yard." We are also proud of our Mumbai police but nowadays in the Mumbai zone, 11 police constables are given duty in the orchestra bar to observe the activity after every hour police officer from the police department gives a visit to the orchestra bar. We are totally confused about whether that is any big crime going on. But no officer is bothered about what is going on in the hookah parlour lounge bar and pub so, we request Mumbai Zone 11 DCP Mr Ajay Bansal Sir to also take a look at the hookah parlours, lounge bar and pubs because young lives are at stake.

# GOLD SMUGGLING: 4,800 GRAMS OF GOLD SEIZED IN 12 HOURS AT KERALA'S KOCHI AIRPORT, WORTH MORE THAN 2 CRORES MS DEPARTMENT ACTION: THE AIR INTELLIGENCE UNIT OF THE CUSTOMS DEPARTMENT SEIZED A HUGE AMOUNT LD AT KOCHI AIRPORT IN KERALA, THE VALUE OF WHICH IS ESTIMATED TO BE MORE THAN TWO CRORE RUPEES.

Air Intelligence Unit: A total of 4,800 grams of gold was seized three times in a span of 12 hours in the action of the Customs Department at Kochi Airport in Kerala. It was seized by the Air Intelligence Unit of the Customs Department. The value of the seized gold has been estimated at Rs 2.10 crore. This information was given by the news agency ANI on Wednesday (April 5).

Gold was hidden in body and underwear

According to other reports, the Air Intelligence Unit (AIU) at Kochi airport seized 3.63 kg of gold, which was smuggled, from two different passengers in a span of six hours. In the first case, officials seized 1812.11 grams of gold brought from abroad from Muhammad Ashraf of Malappuram, reported TOI. The passenger had reached Kochi by Air India flight from Dubai at 8.30 pm.

He was caught in the green channel on the basis of information provided by the Directorate of Revenue Intelligence (DRI). The passenger had hidden four gold capsules weighing 1157.32 grams inside the body and gold paste weighing 654.79 grams in his underwear.

So much gold recovered from another passenger

In another case, 1817.93 grams of foreign gold was seized from a passenger named Muhammad Nafees of Malappuram. This passenger also came from Dubai, who reached Kochi by 'Fly Dubai' flight at 2.10 am on Wednesday. This passenger also kept four gold capsules hidden in his body and gold paste in his underwear.

Let us tell you that on March 18, the Air Intelligence Unit of the Customs Department at Kochi Airport had seized a huge amount of gold from two passengers living in Malappuram in two separate cases. A total of 2669.38 grams of gold was seized, the value of which was estimated at Rs 1.40 crore. The first accused, identified as Abdul Salim, had reached Kochi from Abu Dhabi. ### MANOJ BAJPAYEE SAYS NOBODY HAS THE 'COURAGE' TO QUESTION HIS INTER-FAITH MARRIAGE WITH WIFE SHABANA: 'SHE IS A PROUD MUSLIM, I AM A PROUD HINDU'

MANOJ BAJPAYEE SPOKE ABOUT HIS MARRIAGE WITH SHABANA RAZA, AND SAID THAT THE SUBJECT OF THEIR DIFFERENT RELIGIOUS BACKGROUNDS DOESN'T COME UP



Actor Manoj Bajpayee said that he doesn't discuss religion with wife Shabana Raza, and that he didn't face any opposition from his family when they decided to get married. Manoj said that his wife is a 'proud Muslim', just as he is a 'proud Hindu', but more than religion, he and his wife bonded over shared values.

He said in an interview with journalist Barkha Dutt, on Mojo Story, "My marriage with Shabana, more than religion, is about the values that we share. And those values we don't talk about. These are unsaid. Tomorrow, if one of us changes our values, our marriage wouldn't last."

Asked if there was any chatter about their inter-faith relationship among family members, Manoj said, "Had there been any, it was not conveyed to me, and it was not made obvious. I come from a Brahmin family, a feudal family. Her family had a lot of reputation and prestige to their name. But surprisingly, none of my family members ever objected to it. Never, till now. And if there's any conversation that is happening with my wife, which has to do with religion..."

He said that his wife isn't particularly religious. "She's spiritual, very, very spiritual. She's a proud Muslim, and I'm a proud Hindu, but it doesn't clash with each other." he added. The actor said in no uncertain terms that he will not tolerate any anti-religion comments, and people around him know that they mustn't make such statements around him, because he will shut them down. "Even if they would've talked about the religion of my wife, they could never have the strength or the courage to speak to me on my face. Because they know that I don't mince my words, I'm very hard, when it comes to anyone talking like that. I come very, very hard. I'm a tough guy then... Doston ke beech bhi agar aisi galat baat karte hain, jo karni nahi chahiye, I don't take it nicely... People still talk about my temper," he said.

The actor also recalled when his daughter his daughter was in the 3rd or 4th standard.

The second death was reported from Pimpri-Chinchwad industrial town in Pune district, said the bulletin. Maharashtra's coronavirus fatality rate stood at 1.82 per cent.

The health department said 485 patients recovered from the coronavirus infection in the last 24 hours, taking their cumulative count to 79,94,545 and leaving the state with an active caseload of 3,874. It said 9,002 new coronavirus tests were conducted in Maharashtra, pushing up their overall count to 8,66,64,387.

Talking about nationwide tally, India reported a 46 per cent spike in daily Covid-19 cases, with 4,435 infections being reported in the last 24 hours. According to the latest health ministry data, the overall tally now stands at 44,733,719. On Tuesday, there were 3,038 new coronavirus infections.

More than 2.2 billion doses of Covid-19 vaccines have been administered so far, out of which 1,979 were administered in the last 24 hours. India had kickstarted its nationwide vaccination drive on January 16, 2021.

CRIMINAL COMPLAINT

Social media influencer Sapna Gill has filed a criminal complaint against Indian cricketer Prithvi Shaw and his friend for allegedly assaulting her with a bat and molesting her on February 15. Gill lodged the complaint before the Andheri Magistrate court in Mumbai, seeking registration of a First Information Report (FIR) against the cricketer and his friend. Additionally, Gill has filed another complaint against two policemen from the Airport police station for not performing their duty by registering an FIR against Shaw and others. She has requested the court to register an FIR against investigating officer Satish Kawankar and Senior inspector of Airport police station Bhagavat Rama Garande. The incident allegedly occurred at a club in suburban Andheri a couple of months ago. After being granted bail in the case registered by Shaw, Gill approached the Airport police station in Mumbai. However, the police did not register her case, which led to her filing a criminal complaint in court.
