# MUMBAI CRIME: BRAVING MOB, STONES, POLICE SPEED AWAY WITH SERIAL CHAIN SNATCHER



In a carefully planned operation, 26 Mumbai police personnel disguised as doctors and patients in ambulances face an angry mob in Ambivali, making it to a level crossing in the nick of time.

The cops put Zakir inside one of the ambulances and prepared to exit the place. So far, none of the civilians had realized that the police were present among them and were apprehending someone.

In an operation that was no less than a dramatic Bollywood police chase, Mumbai police officers from Zone XI disguised themselves as doctors and patients in ambulances to nab two alleged chain snatchers from Ambivali on Saturday, February 4. In a carefully timed exercise that lasted just a few minutes, the police party of 26 caught one of the two accused, identified as Sayyed Zakir alias Sanga.

Zakir belongs to the so-called Irani gang and has 27 cases of chain snatching and cheating registered against him, three of which were registered in 2022. Zakir was traced to Ambivali with the help of footage from several CCTVs and information received by MHB Colony police's Assistant Police Inspector (API) Suryakant Pawar. Considering that many such plans of the police have failed in Ambivali, senior inspector Sudhir Kudalkar, API Pawar, and API Akhilesh Bombe, under the guidance of Zone XI Deputy Commissioner of Police (DCP) Ajaykumar Bansal, recced the area few times and gathered information about the accused.

Zakir was produced in court on Monday and has been remanded to police custody. His family told him mid-day that Zakir is innocent and that the actual criminals implicated him to save their skin. They blamed factionalism in their community for Zakir's arrest.

Mumbai Crime News: A special POCSO court has recently sentenced a murderous father who repeatedly raped his 13-year-old daughter to 17 years in prison.

**Mumbai:** A special POCSO court has recently sentenced a murderous father who repeatedly raped his 13-year-old daughter to 17 years of imprisonment. Special Judge A. Z. Khan rejected it.

'I have the responsibility of taking care of my second wife and four children. Therefore, mercy should be shown in the punishment', the accused requested after the court found him guilty. However, the crime was not committed by the accused under pressure or because the victim girl instigated him. When the minor girl was in the custody of the accused, he repeatedly tortured her while he was responsible for her care and maintenance. Therefore, he does not

deserve any mercy in the case of this very serious crime', the judge mentioned in his decision.

'After the death of my first wife, I married her second wife against the opposition of her parents. Out of that anger, they have implicated me in a false case', the defense was made by the accused. However, no evidence has been given by the accused as to why the minor victim made such serious allegations against his own father, and how if those allegations are false. On the contrary, the victim's allegations and testimony about it are very reliable and the complainant's testimony is also helpful to him', the judge convicted the accused.



## ADANI ENTERPRISES SHARES JUMP 25% DAY AFTER ANNOUNCEMENT TO PREPAY LOANS

The group owned by tycoon Gautam Adani lost around \$120 billion in value after claims of accounting fraud were leveled by short-seller US investment group Hindenburg Research on January 24.

Mumbai: Shares in the flagship firm of troubled Indian conglomerate Adani rocketed as much as 25 percent Tuesday, clawing back some of its recent huge losses, after saying it would repay more than \$1 billion in loans.

They pared back some of the gains after transactions resumed, but remained 15 percent up in afternoon trade - although still down by more than half since the start of the year. Other group companies were mixed, with Adani Transmission rising five percent before falling and Adani Total Gas down five percent, and trade suspended again.

"The markets are happy that they prepaid a chunk of their borrowings. This is a refreshing sign of confidence," markets commentator Srinath Sridharan told AFP. Traders said investors would be closely watching earnings announcements due this week from several Adani firms for clues on their financial health.

# NEW YORK WOMAN FOUND ALIVE AT THE FUNERAL HOME AFTER BEING DECLARED DEAD



The case has been referred to the state attorney general's office for investigation, the statement said.

An 82-year-old woman was found alive at a funeral home three hours after she was pronounced dead at a hospital in New York, the authorities said.

On Saturday, at 11:15am, the woman was declared dead at the Water's Edge Rehab and Nursing Center in Port Jefferson, Long Island, New York, according to the press statement released by Suffolk County police.

"The woman, whose name was not released, was taken to the OB Davis Funeral Homes in Miller Place at 1:30pm. She was discovered

breathing at 2:09 pm," the statement added. The case has been referred to the state attorney general's office for investigation, the statement said. It is the second time that the case of apparent premature declaration of death has made the headlines in the US media. In January, a 66-year-old woman was found alive and gasping for air in a bag at a funeral home after she was declared dead at a hospital in Iowa. According to the New York Times report, the woman was declared dead on 3 January at the Glen Oaks Alzheimer's Special Care Center in Urbandale, Iowa. She was placed in a body bag and taken to the Ankeny Funeral Home & Crematory. The funeral home's staff members then unzipped the body bag and found that the woman was alive and gasping for air.
