US COURT APPROVES EXTRADITION OF 26/11 MUMBAI ATTACK ACCUSED TAHAWWUR RANA TO INDIA



GTON: A federal court in the United States has agreed to extradite Tahawwur Rana, a Canadian businessman of Pakistani origin, to India. Rana is sought by India for his involvement in the 2008 Mumbai terror attacks. The court's order, issued by US Magistrate Judge Jacqueline Chooljian, certifies Rana's extradition under the India-US extradition treaty. The extradition decision comes slightly over a month before Prime Minister Modi's scheduled state visit to Washington DC where he will be hosted by President Joe Biden and First Lady Jill Biden for a state dinner on June 22. Tahawwur Rana has been accused by India of participating in the planning and execution of the Lashkar terrorist ttacks in Mumbai by collaborating with his childhood buddy David Coleman Headley, also known as "Daood Gilani," and others. Rana was convicted in Chicago in 2011 of providing material support to the Pakistan-based terror group Lashkar-e-Taiba, which planned the Mumbai

He was accused of allowing David Coleman Headley to open a branch of his Chicago-based immigration law business in Mumbai as a cover story and travel as a representative of the company in Denmark. The court's 48-page order said that Rana should be extradited to India based on the extradition treaty between the two countries. After reviewing all the relevant documents and arguments presented during the hearing, the court certifies Rana's extra stability on the charges brought against him. he court has reviewed and considered all of the documents submitted support of and in opposition to the request and has considered the nts presented at the hearing. Based on such review and onsideration and for the reasons discussed herein, the court makes the findings set forth below, and CERTIFIES to the Secretary of State of the United States the extractability of Rana on the charged offences that are the subject of the request," the order said. India had initially filed a complaint on June 10, 2020, seeking Rana's provisional arrest for the purpose of extradition, a request that was supported and approved by the Biden administration. When asked about the case, a spokesperson for the State Department referred the query to the Department of Justice but expressed the United States' commitment to combating terrorism globally and its strong counterterrorism relationship with

Vipul Shah and Sudipto Sen, producer and director respectively of the blockbuster movie "The Kerala Story," showcased 26 victims of Islamic radicalisation in a press conference held on Wednesday. These women were specially brought from Kochi to Rang Sharda Hall in Bandra where they were presented before the media. Shruti, one of the women associated with Aarsha Vidya Samajam, revealed that their organization as successfully reintegrated over 7.000 women back into the Hindu faith in Kerala. In response to criticism regarding the claim of 32,000 non-Muslim women being converted to Islam, Shah stated that more details are surfacing following the movie's release.

This press conference marks the beginning of an effort to substantiate the claim of large-scale conversions of women to Islam, not just in Kerala but across the nation," Shah stated. He also announced a donation of Rs 51 lakhs to the Samajam to support their "Protect Ou Daughters" campaign. Shah urged every Indian to watch "The Kerala Story" with their families, emphasizing that the film isn't solely about three girls who were converted and radicalised but also sheds light on the fate of thousands of other women across India.

The film not targeting Islam, but is made to address terrorism

Director Sen clarified that the film wasn't targeted at Islam but aimed to address the threat of terrorism, which poses a significant danger to the nation. Shruti, a victim of Islamic conversion herself, emphasized that love jihad is a harsh reality that cannot be ignored. She stated that their organization frequently encounters unsuspecting women who are manipulated and compelled to adopt an "anti-humanistic" ideology Out of the 7,000 women who reconverted to Hinduism, 25 have dedicated their lives to preventing other women from falling into the trap of love jihad.

Sen explained that "The Kerala Story" isn't confined to Hindus Muslims, or Christians but represents the struggles of numerous girls who are enticed and brainwashed. Some of the women present on the stage had their faces covered to protect their identities

THE LIC TANKS 35% IN 1 SINCE MARKET DEBUT

Mumbai: Shares of Life Insurance Corporation (LIC) have fallen 35% from the listing day and nearly 40% from the IPO price of Rs 949. The Rs 2.4-lakhcrore loss in market cap since its listing on May 17, 2022 brackets LIC's listing among the worst first-year performances by a public sector stock. For years, LIC was speculated to be the most valuable financial institution in India, considering it was the largest in terms of assets under management. The corporation was among the most recognised brands in the financial sector and had more policyholders than the population of Brazil. However, the moment of truth exactly a year ago during its IPO when it turned out that, going by its upper band

price, the government had valued LIC at around Rs 6 lakh crore, which was lower than many private sector companies. A year after listing, the corporation's mcap has dipped to Rs 3.6 lakh crore – less than that of private sector companies like Bajaj Finance and Kotak Mahindra Bank, and 13th in terms of the most valuable companies in the country. LIC is more sensitive to equity movements as compared to listed peers A 10% decline in its equity portfolio will lead to a 6.5% fall in embedded value (and a 2.7% fall in the value of the new business) as compared to a dip of 1.5-2% (0.2-0.6%) for major listed peers," said Caps in a research Embedded value measures the intrinsic worth of a life insurance company taking into account future revenues and liabilities.
