#### HEATWAVE PREVAILS IN CITIES ACROSS INDIA, MAXIMUM TEMPERATURE HOVERS OVER 40 DEGREES CELSIUS

NDITIONS CONTINUED TO PREVAIL IN VARIOUS COUNTRY INCLUDING DELHI, BIHAR AND WEST ENGAL. DELHI'S SAFDARJUNG OBSERVATORY, IAXIMUM TEMPERATURE OF 40.4 DEGREES CELSIUS. RECORDED



Heatwave conditions continued to prevail in various parts of the country including Delhi, Bihar and West Bengal with the temperature hovering in the range of 40 to 44 degrees Celsius. Hamirpur and Prayagraj in Uttar Pradesh were bowling at 44.2 degrees Celsius. In Odisha, all schools up to class 12 both Government Aided and Private along with all the Anganwadi Centre will remain closed on April 19-20 in view of the prevailing heatwave conditions in the state. Indian Meteorological Department, Bhubaneswar has issued the alert for a Heat wave for net of 2 to 3 days.

In Delhi, heatwave conditions continued for the third consecutive day in several parts on Tuesday. Some weather stations recorded the maximum temperature at least five degrees Celsius above normal. According to India Meteorological Department, cloudy weather and light rain may provide some relief from the heat on Wednesday.

Delhi's primary weather station, the Safdarjung Observatory, registered a maximum temperature of 40.4 degrees Celsius, four notches higher than the school will refund the fees once it receives the amount from the normal. This is the fourth consecutive day that the maximum temperature settled above 40 degrees Celsius in the national capital. The Pusa and Pitampura areas experienced heat wave conditions with maximum temperatures settling at 41.6 degrees to 41.9 degrees Celsius, respectively, as reported by the news agency PTI.

The threshold for a heatwave is met when the maximum temperature of a station reaches at least 40 degrees Celsius in the plains, at least 37 degrees Celsius in coastal areas, and at least 30 degrees Celsius in hilly regions, and the departure from normal is at least 4.5 degrees Celsius. The IMD said a western disturbance active over the western Himalayan region is predicted to bring light rain in the northwestern plains starting Tuesday, as reported by PTI.

The meteorological department has issued an 'orange' alert with a warning of severe heatwave conditions for two days from Tuesday in Patna, Banka, Jamui, Nawada, Aurangabad, Supaul and several other districts of Bihar, as deposit the fees to the parents' account or cancel the licences and reported by PTI. Admission to private schools under the RTE Act's reservation for the economically weaker section is not guaranteed. A case from Kolhapui district's Gadhinglaj city is proof of that. A CBSE school there broke two rules at one go-first, it demanded fees and then refused admission when the applicant's father could not pay. According to the state government rules, 25 per cent of seats at

private and public schools are reserved for students from

economically weaker sections (EWS), who are entitled to free education, under the RTE Act. The government pays up to Rs 17,000 per student annually until s/he is promoted to Std VIII. In Gadhinglaj, Ganpat Gaikwad got confirmation of his daughter's free admission to Sarvodaya Vivek Jeevan Vidya Public School. However, on Monday, when he went to enrol her in Std I, the administration asked him to pay the full fees. The administration told Gaikwad that

the state school education department with the help of an NGO. "I was overjoyed when I went to the school to enrol my daughter because it meant she could attend a reputable institution. My joy, however, was short-lived. I was informed that she would get admission only if I paid an annual fee of Rs 40,000 and signed an undertaking to

# GOOGLE MAY LAUNCH PIXEL FOLD, ITS SAMSUNG GALAXY Z FOLD 4 RIVAL, IN JUNE

GOOGLE IS SET TO HOST THE GOOGLE IO 2023 EVENT ON MAY 10, WHERE THE COMPANY IS EXPECTED TO LAUNCH ITS FIRST FOLDING SMARTPHONE, REPORTED TO BE CALLED THE PIXEL FOLD. AHEAD OF THE OFFICIAL ANNOUNCEMENT, NEW DETAILS ABOUT THE SMARTPHONE HAVE SURFACED, INCLUDING ITS LAUNCH TIME AND SPECIFICATIONS.

ACCORDING TO AN INTERNAL DOCUMENT OBTAINED BY CNBC, THE GOOGLE PIXEL FOLD IS LIKELY TO BE UNVEILED AT GOOGLE IO 2023, BUT THE OFFICIAL LAUNCH WILL TAKE PLACE SOMETIME IN JUNE. IT COULD MEAN THAT GOOGLE MIGHT HOST A STANDALONE EVENT FOR THE PIXEL FOLD WHERE THE EXACT LAUNCH DATE WOULD BE REVEALED. THE PIXEL FOLD WILL REPORTEDLY COST OVER \$1,700 (ROUGHLY RS 1.40 LAKH). THE REPORT STATES THE GOOGLE PIXEL FOLD, INTERNALLY CODENAMED FELIX, WILL HAVE A "DURABLE HINGE" WITH A "WATER-RESISTANT" BODY. UNLIKE THE GALAXY Z FOLD 4, THE PIXEL PHONE IS SAID TO BE MUCH MORE COMPACT WITH A SQUARISH DISPLAY
