

INFORMERS TROUBLING THE HOTELIERS TO RUN THEIR HOTELS SMOOTHLY

CRIME NEWS: 4 SUSPECTS ARRESTED IN SEVERAL THEFT CASES INCLUDING MURDER

THEY ARE ACCUSED IN AROUND 10 THEFT CASES IN KULASEKHARAM, ARUMANA, TIRUVATTAR AND MARTHANDAM POLICE STATIONS.

Thiruvananthapuram: Four accused in several theft cases including murder related to ration smuggling have been arrested. They were arrested in Kanyakumari. Klein, a resident of Kallampottavila, Mahendra Kumar, a resident of Marayapuram, Karthik Selvam, a resident of Tamarakulam, and Jagan, a resident of Tripparar, were arrested.

They are accused in around 10 theft cases in Kulasekharam, Arumana, Tiruvattar and Marthandam police stations. The accused were arrested by the team of SI Arulapan under the leadership of district police chief Hari Kiran Prasad. Similarly, the accused Klein and Mahendra Kumar are accused in the Ration Arikadat murder case.

Gold ornaments, 1000 kg of rubber sheets, four warps, rolls, cars, bikes etc. have been recovered from them. The accused who were arrested and taken to Kulasekharam station were produced before the court and remanded.

When the thieves who were hiding behind the generator in front of the bank approached Shah, they stole the package in his hand. They passed on the scooter which had been started. Shah ran behind but was not caught. Both were wearing helmets. The number plate of the scooter had been changed.

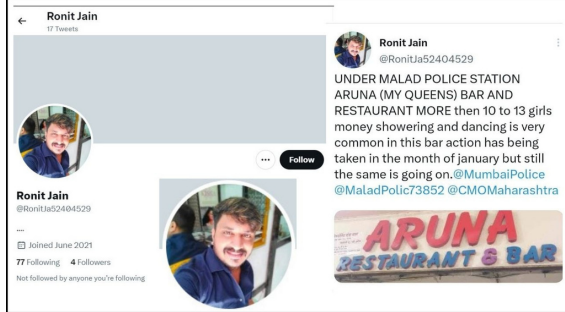

RAHUL GANDHI: WILL HE FACE LONG LEGAL BATTLE? REMEDIES AVAILABLE, DISQUALIFICATION PROCESS EXPLAINED



WHAT DID THE COURT ORDER SAY?
In its order, the court noted that the seriousness of the accused's crime increased because a speech delivered by a member of parliament has a "very wide impact on the public." "And if the accused is given less punishment, then it sends a wrong message to the public and the purpose of defamation is not fulfilled and anybody will easily slander someone." The court also said the Supreme Court had in the past asked the accused to remain alert in the future after he apologised in a 2018 case for his 'chowkidar chor hai' remark.

Gandhi's lawyer argued for a lesser punishment claiming there was no intention to insult anyone. Gandhi returned from Surat to the national capital in the evening and was accorded a reception at the domestic airport in Delhi on his arrival.

WHAT ABOUT HIS MP STATUS?
Gandhi can escape immediate disqualification as a member of parliament if the appellate court suspends the conviction as well as the two-year jail term. As the conviction ahead of the 2024 Lok Sabha elections set off a political slugfest and posed another challenge to Gandhi with a bearing on his political future, the Congress said he will file an appeal.

According to the Representation of the People Act, a person sentenced to imprisonment of two years or more shall be disqualified "from the date of such conviction" and remain disqualified for another six years after serving time. P D T Achari, a former Lok Sabha Secretary General and Constitution expert, told PTI if the appellate court stays the conviction and the sentence then the disqualification will remain suspended.

WHAT ARE THE LEGAL REMEDIES AVAILABLE TO GANDHI?
According to an India Today report, the decision of conviction can be contested before a higher court where the appeal sits within the legal system outlined in the Code of Criminal Procedure (CrPC).

ASSAM: MASSIVE SEX RACKET BUSTED IN NAGAON, 17 HELD

THE RACKET WAS BEING RUN OUT OF A DHABA ON NAGAON'S BARGHAT BYPASS.



GUWAHATI: On March 23, Nagaon police announced that they had uncovered a prostitution ring and had detained 17 suspects, including a dhaba owner, who were reportedly responsible for running the illicit business. The racket was being run out of a dhaba on Nagaon's Barghat bypass. After some police officers conducted a raid at the Bhogdoi dhaba on the basis of a tip, the lid blew off. Leena Doley, the Nagaon SP, told the reporters that "we have got various tips regarding this unlawful activity running at Bhogdoi dhaba." Following the raid, up to 17 people who were allegedly clients, brokers, or workers of the dhaba engaged in this trade have been detained. Along with the primary broker, Dulal Ahmed, the dhaba's owner, Ratul Hazarika, has also been detained. The SP further stated that five women who were saved were coerced into this line of work and would be sent for counselling with the court's approval.

Both the dhaba owner and the broker who participated in the trade are the targets of a human trafficking prosecution. When questioned, the clients confessed to the offence and claimed that the broker, Dulal Admed, used to give them access to ladies in exchange for payment. In Assam, 203 cases of human trafficking were reported, while 349 traffickers were detained in 2021. These startling details were given by Ajay Kumar Mishra, Minister of State for Home Affairs, in response to a question posed by Arunachal MP Tapir Gao during a Lok Sabha Question Hour session. Crime in India, the National Crime Records Bureau's annual publication, compiles crime statistics that have been submitted to it by the States and Union Territories (UTs). Information on instances and suspects detained under the Human Trafficking Act in the North Eastern States, including the State of Assam, for the year 2021 reveals that Arunachal Pradesh reported three crimes and detained five suspects.

DARGAH IN MUMBAI COASTAL AREA DEMOLISHED AFTER RAJ THACKERAY'S COMPLAINT

A Maharashtra minister said necessary action was initiated under the laws defined in Coastal Regulation Zone Act.



Mumbai: The Brihanmumbai Municipal Corporation (BMC) on Thursday demolished a dargah in Mumbai's Mahim coastal area after Maharashtra Navnirman Sena (MNS) president Raj Thackeray claimed it was being built on an encroached land. Visuals showed the dargah being razed by a bulldozer and the spot being cleared. Maharashtra Minister Deepak Kesarkar said necessary action was initiated under the laws defined in Coastal Regulation Zone (CRZ) Act. Addressing a press conference, he said, "We respect all religions. We have taken this action keeping in mind the Coastal Regulation Zone (CRZ) Act. There is nothing wrong with it. It is the CRZ act which prohibits the construction of anything in the sea. The remaining stones will be removed from the area and the spot will be cleaned." He further stated that the Maharashtra government is walking on the path of Balasaheb Thackeray. "Our government runs on the vision of Balasaheb Thackeray. Balasaheb Thackeray used to raise these issues and now Raj Thackeray raised them. Due to Raj Thackeray, it came to our notice that the violation of CRZ is going on, so we took action so that no one in future repeats these actions," he said. Earlier, Raj Thackeray had pointed out a dargah was under being built at the Mahim coast. The Maharashtra Navnirman Sena on Wednesday said that action should be taken by state authorities and if the dargah is not demolished then MNS will build a Ganapati temple at the same spot. "After seeing this, take immediate action, demolish this unauthorized construction. Otherwise, we will build a big Ganapati temple there," the official Twitter handle of MNS tweeted with a video.

PAZHAYIDAM DOUBLE MURDER: A RARE CASE OF RARES; DEATH PENALTY FOR THE ACCUSED IN THE OLD CASE

The accused, who was on bail, was earlier arrested by the Tamil Nadu police and brought to Kerala, this was also a theft case.



Kottayam: Death sentence to the accused in the double murder case. Accused Churapaddy Arun Sasi was sentenced to death by the Kottayam Additional Sessions Court. The court pronounced the verdict after observing that it is a rare case. A fine of Rs. 2 lakh will also be levied on the accused. The court also stated that the person he was supposed to protect committed a brutal murder. The court found the defendant guilty of serious criminal charges including murder, theft and housebreaking. The incident related to the case took place on August 28, 2013. The accused's paternal sister Thankamma and her husband Bhaskaran Nair broke into the house and killed them by hitting them on the head with a hammer. The intention was to take the money and gold from the house. Meanwhile, the accused escaped to Chennai on bail after being remanded. After this he was arrested by the Chennai Police and handed over to the Kerala Police. Although the defendant pointed out that the husband of Arun's only sister is suffering from cancer and Arun is the only one who can help him, the court did not consider this. The counter argument raised by the prosecution is that his circumstances should not be considered. Police say the accused committed the crime for money to buy a car. He was caught in a necklace theft case in Kottayam. Police understand the suspect's long string of crimes. He was bailed in 2014 and was picked up by the police in another theft case from Tamil Nadu in 2016.
