#### LERS TARN CHIEF PT USH TARNISHING ESTING IMAGE: I FRS HIT BACK: OUR DEMOCRATIC RIGHT UNFORTUNATE USHA CAN'T UNDERSTAND PAIN OF WOMEN ATHLETES.

On the day an ad-hoc committee took over the wrestling administration, Indian Olympic Association president PT Usha said sportspersons "protesting on the streets" amounted to indiscipline and were tarnishing the image of the country. This came after Sports Minister Anurag Thakur had insisted that "Prime Minister Narendra Modi ji's govt has always stood with players" and "sports and athletes are their priority".

Speaking to reporters after the IOA's Executive Committee meeting that nominated Wushu Association of India president Bhupendra Singh Bajwa, former shooter Suma Shirur and a retired High Court judge to run the wrestling body



and hold elections, Usha said: "The IOA has an athletes' commission. Instead of going on the streets, they would have come tous. The wrestlers themselves suggested an ad-hoc committee and we have formed one '

"They should have come to us. If they didn't get a solution, they could have gone everywhere. Straightaway going to the streets is not good for sports. We don't want any problems with our sportspersons. We want our athletes to participate in the Asian Games.

'This kind of agitation is not good for the country's image and amounts to indiscipline. This negative publicity is not good for the country. We want to be with any athlete who has represented India but under the rules, regulations and law of the land."

Sports minister Thakur said the government has always stood with athletes. "We wanted an independent probe. Anyone who wanted to speak in front of the oversight committee was given the chance to speak. There was no restriction. The time period of the probe increased because of them, we allowed that. There were 14 meetings of the oversight committee. Police have said it will do a preliminary enquiry before lodging FIR," he said. The statements made by the former sprint queen didn't go well with the wrestlers protesting at Jantar Mantar. "I am extremely disappointed with PT Usha making such statements, being a woman and former athlete. It's unfortunate that as a woman she is not able to understand the pain these women are undergoing," Olympic medallist Bajrang Punia said.

Jiah Khan suicide case verdict by CBI court likely today: What we know

After almost a decade, a special Central Bureau of Investigation (CBI) court in Mumbai is likely to give its verdict in connection with the death of actor Jiah Khan on Friday. The actor was found dead at her residence in Mumbai on June 3, 2013.

Last week, special CBI judge AS Sayyad, after hearing the final arguments of both sides, reserved his judgment in the case for April 28.

Based on a letter seized on June 10, 2013, which was purportedly written by Jiah Khan, 25, the Mumbai Police had booked actor Soorai Pancholi under Section 306 (abetment to suicide) and arrested

Sooraj, son of actors Aditya Pancholi and Zarina Wahab, was allegedly in a relationship with Jiah, best known for her performance in Amitabh Bachchan starrer 'Nishabd'. Jiah's mother Rabia Khan alleged that her daughter was murdered.

# NAVI MUMBAI: METRO SERVICES START SOON AS TRIALS CONCLUDE

DNCE THE CMRS ISSUES CERTIFICATION, THE DECK WILI RED FOR THE COMMERCIAL OPERATION OF THE MUMBAI METRO



The dream of Navi Mumbaikars to enjoy metro rides will soon be fulfilled as the commissioner of metro railway safety (CMRS) concluded the final test for the whole stretch of line one of Navi Mumbai Metro on Tuesday. Once the CMRS issues certification, the deck will be cleared for the

commercial operation of the Navi Mumbai Metro. The CMRS started the final test of the whole stretch on April 17 in phases

The test was concluded on Tuesday, April 25. It included rolling stock, electrical, civic, security and others.

#### CMRS clearance necessary for commercial operation

The clearance from CMRS is important for the commercial operation of the Metro. The Navi Mumbai metro was delayed due to multiple reasons. Even the planning agency had to blacklist one of the contractors.

Of the 11 km stretch of line 1, around 5.3 km from Pendhar to Central Park in Kharghar will be tested and opened to the public after getting approval. Following the project being delayed due to a number of reasons including blacklisting the contractor, CIDCO appointed MahaMetro for the completion of the remaining work and starting the operation. Meanwhile, CIDCO continues to provide all necessary support.

The project got momentum after MahaMetro took up the work for the Belapur-Pendhar route. So far, the Metro has completed trials related to oscillation, electrical safety, emergency brakes, etc. successfully and obtained certificates from the RSDO.

#### lavi Mumbai Metro fare

The fare of Metro line 1 starts at ₹10 and the planning agency claims that this fare is lower than the fare of air-conditioned buses of NMMT for the same distance. As per the decision, commuters will have to shell out ₹10 for a distance of up to 2 km. Similarly, from 2 to 4 km, the fare will be ₹15. For every 2 km, there is a rise of ₹5 in the fare. However, beyond 10 km, the fare will be ₹40.

Phase 1 of Navi Mumbai consists of 11 stoppages covering a distance of 11.1 km from Belapur to Pendhar (near Taloja).

MUMBAI: OVER 300 ILLEGAL PAAN BEEDI SHOPS TORN DOWN IN THREE DAYS FIRS FOR RUNNING UNLICENSED SHOP FOUND THEM ILLEGAL AFTER YEARS



In a three-day joint operation launched on Tuesday, a team of city cops and civic officials demolished over 320 illegal pan and beedi shops, including those located within 100 yards (approximately 100 metres) of schools and colleges. The police have registered 35 FIRs so far, officers said on Thursday.

Also, 1,766 people have been fined for smoking in public places under The Cigarettes and Other Tobacco Products Act (COTPA), 2003. Joint Commissioner of Police (law and order) Satyanarayan Chaudhary told mid-day, "This operation will continue. We won't let anyone run pan beedi shops illegally." On Thursday, the Gamdevi police and officials from D ward demolished the popular pan shop, Muchhad Paanwala, along with two others near Stefan Church at B D Road in south Mumbai.

#### 'Why did they wake up now?'

A shop owner near Chetna college, Bandra East, said, "We had been running our shop for years, but the authorities only now realised that these were illegal. The BMC demolished my stall and the police seized everything that was in there." He had been paying rent to the owner of the bar outside where he had his stall.

Another shop owner from Bandra West said, "Every new babu comes up with a new law just to harass poor people like us. We have been selling cigarettes and pan to cops and civic officials too, but the same people are destroying the businesses

A 55-YEAR-OLD PROPERTY DEALER HERE IN SOUTH DELHI'S NEB SARAI AREA ALLEGEDLY HACKED HIS WIFE TO DEATH WITH AN AXE AND TRIED TO KILL HIS TWO CHILDREN INJURING THEM BOTH IN THE NECK, POLICE SAID ON THURSDAY VIJAY VEER, THE ACCUSED, OFTEN USED TO HAVE A ROW WITH HIS 50 YEAR-OLD WIFE OVER DOWRY, AND AFTER ONE SUCH FIGHT THURSDAY, HE ATTACKED HER WITH AN AXE WHILE SHE WAS ASLEEP, THEY SAID.
